**3. Annual Financial Report**

Treasurer Jon Mack, presented the annual financial report, previously circulated. MCPRA ended 2022/2023 with assets of approximately \$217K. However, much of this amount has been committed and will be expensed in 2023/2024. We ended 2022/2023 with approximately \$30K of uncommitted funds.

A vote to accept the Financial Report was moved by Sue Hale, seconded by Alexa Ives and carried by all. Tax returns have been submitted and Jon is investigating a recent CRA notice that we are not eligible for HST rebates as a nonprofit organization.

**4. Appointment of the Individual Conducting the MCPRA Financial Review**

Jim Stewart was again recommended to conduct the MCPRA Financial Review, on a motion by Jon, seconded by Wendy and carried.

**5. 2023 Project Update Report**

Anne Robinson mentioned that the report previously circulated covers everything that we accomplished last year. She thanked everyone including the many volunteers behind the scenes that help produce Chic Time, the outdoor rinks, park clean-ups, tree planting, and more.
